Amend the 2020 Permanent Budget

Mr. Eric Richter presented the amendment to the 2020 permanent budget for Washington Township. This amendment is being made to account for Federal COVID dollars the township will receive via H.B. #614. H.B. #614 is the final distribution of approximately \$650 million CARES Act funding to local governments via Ohio General Assembly action. These dollars will be distributed using the existing Local Government Fund Formula. In order to appropriate and spend these funds, an amended Certificate of Estimated Resources must be filed with the Franklin County Budget Commission accounting for the additional estimated grant receipts totaling \$36,469. With the addition of this revenue, total CARES Act/COVID funding will be \$103,474 for 2020.
