Resolution to Join MORPC:

Mr. Kranstuber introduced and moved the adoption of the following Resolution:

A RESOLUTION AUTHORIZING AND DIRECTING THE TOWNSHIP ADMINISTRATOR TO EXECUTE THE NECESSARY PAPERWORK TO HAVE WASHINGTON TOWNSHIP JOIN THE MID-OHIO REGIONAL PLANNING COMMISSION (MORPC).

WHEREAS, the Board of Trustees recognizes the need for collaborative, cooperative planning in order to ensure continued growth and prosperity; and

WHEREAS, the Mid-Ohio Regional Planning Commission's Mission Statement indicates it is "The regional voice and a catalyst for sustainability and economic prosperity in order to secure a competitive advantage for central Ohio"; and

WHEREAS, the Mid-Ohio Regional Planning Commission currently includes over 60 local governments and has for over 60 years addressed challenges and opportunities associated with growth and development in central Ohio, as well as working with its members to improve the quality of life within the region; and WHEREAS, the Board of Trustees of Washington Township believes it would be advantageous for Washington Township to join the Mid-Ohio Regional Planning Commission and to take advantage of the opportunities provided within that organization as a means of benefitting the citizens of Washington Township.

NOW, **THEREFORE**, **BE IT RESOLVED** by the Board of Trustees of Washington Township, Franklin, Delaware, and Union Counties, State of Ohio:

SECTION 1: The Board of Trustees hereby authorizes and directs the Township Administrator to execute necessary documentation to join the Mid-Ohio Regional Planning Commission. Furthermore, the Board of Trustees hereby appoint Eric Richter, Township Administrator, as their representative to the Mid-Ohio Regional Planning Commission.

SECTION 2. It is hereby found and determined that all formal actions of this Board concerning and relating to the passage of this Resolution were adopted in an open meeting of the Board and that all deliberations of the Board and any of the decision making bodies of the Board of Trustees which resulted in such formal actions were in meetings open to the public in compliance with all legal requirements of the State of Ohio.
