Regular meeting of the Washington Township Board of Trustees was held at the Washington Township Administration Building, 6200 Eiterman Road, Dublin, Ohio, on May 28, 2019, at 6:00 p.m. Meeting was called to order by Mr. Charles Kranstuber, Chair, and the meeting opened with the Pledge of Allegiance.

Resolution to Amend and Replace Credit Card Policy:

Mr. Kranstuber introduced and moved the adoption of the following Resolution:

A RESOLUTION AMENDING AND REPLACING THE WASHINGTON TOWNSHIP CREDIT CARD POLICY TO INCLUDE ADDITIONAL PROCEDURES REGARDING THE USE OF GASOLINE CREDIT CARDS

WHEREAS, with Resolution No. 2018.12.11.017, the Board of Trustees adopted an amended credit card policy in order to comply with new requirements set forth by House Bill (H.B.) 312 of the 132nd General Assembly, Section 1, safeguarding the Township against credit card fraud and abuse, and promoting responsible acquisition, management, and use of Township credit cards; and

WHEREAS, recently, at least one station in the Township's Fire Department has requested the assignment and use of a gasoline credit card, specifically to be used for the purchase of fuel for Township fleet vehicles; and

WHEREAS, although H.B. 312 excludes gasoline credit cards from regulation by policy, the Township believes it is the best practice and in the best interest of all employees and residents to set forth the procedures for assignment and use of gasoline credit cards under the new credit card policy; and

WHEREAS, the Board of Trustees now wants to amend its current credit card policy to include additional procedures regarding the use of gasoline credit cards.

NOW, **THEREFORE**, **BE IT RESOLVED** by the Board of Trustees of Washington Township, Franklin, Delaware, and Union Counties, State of Ohio:

SECTION 1: The Board of Trustees hereby amends and replaces the Washington Township Credit Card Policy as set forth in the document entitled "Washington Township Credit Card Policy" attached hereto

as Exhibit A and incorporated by reference.

SECTION 2: The Board of Trustees hereby expressly declares that the Washington Township Credit Card Policy attached hereto as Exhibit A shall serve as the exclusive written policy of the Township for the use of credit card accounts, shall supersede any and all other written policies related to the use of credit card accounts, and shall apply to all employees, officers, and departments of the

Township.

Round Table Discussion:

Mr. Eric Richter gave an update on the Amlin Community Clean-up Project and he advised the Board about the public auction of the Pizza Shop in Amlin. The Board has an interest in bidding on the property to improve Amlin. There are three options the Township has with this property; Option #1 – To do nothing. Option #2 - Raise it. Option #3 - Try to improve it. Mr. John Brown resident of Amlin stated it does have a new septic system. He stated he hates to see the Pizza Shop torn down. The Trustees feel this property is not a viable property for commercial because there is no parking. Mr. Richter said the auction closes on June 10, 2019. Trustees think it would be nice just to have a green space at this location.

Mr. Richter stated in just under two months, existing Washington Township staff have initiated written communications to residents within the Amlin overlay district, solicited information via a questionnaire/survey, conducted a community meeting, and coordinated a clean-up weekend for the area. Based on feedback from previous meetings, it appears the Board is looking for specialized expertise related to planning, engineering, landscaping, and neighborhood beautification projects to assist the Township in identifying and prioritizing critical issues raised during the questionnaire and meeting process conducted in April and early May.

Mr. Richter presented a draft of an RFP which encompasses the scope of services the Board would like to see achieved and a discussion was held. Noting: Draft RFP appended to the meeting Minutes.

Motion Personnel:

Motion by Ms. King, seconded by Mr. Bostic, the Washington Township Board of Trustee accept and implement the recommendation of the staff and Township's legal counsel regarding Fire Fighter Jeremy J. Ross as listed;

- 1. Starting at 8 a.m. on June 4, 2019, FF Ross is suspended, without pay and without supplementing accrued paid time off, for a 140-hour consecutive period or 5 duty days. As such, he will not report to work again until 8 a.m. on June 19, 2019;
- 2. Within the next fourteen (14) days, a professionally licensed psychologist or psychiatrist must evaluate and opine whether he is fit-for-duty as a firefighter. If the psychologist or psychiatrist opines it is necessary for FF Ross to continue counseling, he must complete the outlined program. The Township will pay for this appointment and evaluation;
- 3. FF Ross must successfully complete an anger management program as determined and paid for by Washington Township. If this initial program recommends him to continue counseling, he must complete the outlined program;
- 4. FF Ross will receive a separate Progressive Counseling Notice for his failure to call or appear for a scheduled shift on April 14, 2019; and
- 5. FF Ross will receive a separate Progressive Counseling Notice for not following a direction.
