#### Minutes of March 11, 2025

#### **Record of Proceedings**

The Washington Township Board of Trustees regularly scheduled meeting held at Washington Township Administration Building, 6200 Eiterman Road, Dublin, Ohio, on March 11, 2025, at 6:00 p.m., with Mr. Jan Rozanski, Chairman, calling the meeting to order, and it opened with the Pledge of Allegiance.

#### Franklin County Deputy Sheriff's Report:

Deputy Burton Haren with Franklin County Sheriff's Office (FCSO) submitted a verbal report to the Trustees for February 28 through March 11, 2025, including an update on the following:

• During this period, there were few traffic stops and an informational report taken off of Fishel Drive. There were no thefts or burglaries during this period.

#### **Opportunity for Residents to Speak:**

Mr. Gene Bostic provided a brief update on the St. John Lutheran Church Proposed Planned Unit Development (PUD). He spoke with a representative of the church's committee who indicated the group will likely meet with the Dublin Planning and Zoning Commission at the next meeting. There was additional discussion surrounding potential use of the secondary land-locked parcel that the church does not intend to use as part of the Memorial.

#### Anna Norfleet, Dublin Scioto Sophomore:

Ms. Norfleet explained that as part of an annual Dublin Scioto High School project to support military veterans, she created a presentation board for Captain Nick Rozanski. Ms. Norfleet outlined that she and her family are close with Nick's wife, Jenny, and their daughters. As she completed the project, Ms. Norfleet was impressed by the impact military service can have on someone's life. The impact on the Rozanski family led to the creation of the Nick Rozanski Memorial Foundation.

Mr. Rozanski expressed his appreciation to Ms. Norfleet for honoring and remembering his son Nick. Mr. Rozanski described his son as a character who matured when he joined the military and took his service very seriously. He outlined Nick's multiple deployments and operations in which he participated. He recounted that this April will be thirteen (13) years since Nick's passing while serving in Afghanistan. Nick's fellow servicemen continue to visit his grave every April 4, spending several hours sharing stories about Nick.

#### **Round Table Discussions:**

#### **Township Administrator Eric Richter:**

- Mr. Richter provided the Board a copy of a notice Mr. Melody received regarding the intent of National Church Residences to partner in a residential development at 4105 Stonebridge Lane.
   Responding to questions, Chief Donahue infers from the notice that this will be an improvement or addition to the property that already exists at the address;
- Mr. Richter updated the Board on funding for the planned Shared Use Path along Shier Rings
  Road. Following voter approval of the COTA levy last November, Mr. Richter was able to secure
  a \$544,300 allocation toward the project through LinkUS funding. To utilize as many of the funds
  toward the project as possible, the timeframe may be delayed dependent on funding
  parameters. Mr. Richter will continue to update the Board as the project progresses;
- Mr. Richter provided the Board an updated Fire Levy Fact Sheet. He indicated a landing page for the levy has also been created on the Township's website at <a href="https://wtwp.com/fire-ems/general/fire-levy/">https://wtwp.com/fire-ems/general/fire-levy/</a>. The webpage includes a bar graph showing Washington Township as the lowest levy cost to residents in Central Ohio, as well as links to the updated fact sheet, ballot language, newly adopted Community Taxation Philosophy and an Economic Impact Study by an Ohio Wesleyan fellow. Mr. Kranstuber expressed his appreciation for the information, and noted that he would have liked to see more statistics and comparisons with accredited agencies that also have ISO-1 designations. Chief Donahue confirmed there are ten (10) total accredited agencies in Ohio and only four (4) with both accredited status and ISO-1 designation.

#### **Chief John Donahue:**

Chief Donahue shared with the Board information on a run from Sunday evening. While the fire
had extinguished itself prior to firefighters arriving, two (2) residents were transported to the
hospital and kept overnight for smoke inhalation after the couple attempted to locate the family
cat upon arrival to a smoke-filled garage. The fire was located near a workspace charging station
in the kitchen, and resulted in an estimated \$200,000 in smoke damage to the home;

- Chief Donahue presented the monthly report for February, noting it is typically a slower month;
- As part of the initiatives resulting from the 2024 Diversity Committee, Chief Donahue outlined
  presentations to local colleges and technical schools on the upcoming part-time hiring process.
  He noted that the strategy generated a lot of interest and hopes to see the positive impact
  when the next hiring process begins;
- Chief Donahue invited the Trustees and Fiscal Officer Melody to join him and the department apparatus that will be in the St. Patrick's Day parade on Saturday;
- Chief Donahue provided an update on the new Medic apparatus that has been ordered, anticipating delivery in August. He explained this will be the final major capital purchase following delivery of a new engine expected this summer.

#### **Fiscal Officer Scott Melody:**

- Mr. Melody recently completed Fiscal Officer training for Municipal Bonds and Commercial Paper. He explained the trainings are required before being permitted to better diversify investments, which may secure better interest rates for the Township. He noted the maximum investment term is five (5) years;
- There was discussion regarding the Township's safe-deposit box at Fifth Third. When visiting the bank, Mr. Melody was informed the box had not been accessed in nearly ten years and the keys did not work. Mr. Melody will update the Board when Fifth Third has provided access;
- Mr. Melody attended the Dublin Chamber of Commerce's Business Advisory Council meeting at Air Force One this morning. He noted the Township is hosting the next meeting on April 22 at 8 a.m. in the Township Administration Building. Mr. Kranstuber indicated the host organization generally holds a brief five to ten minute discussion following a message from the Dublin City Schools Superintendent, and recommended a fire apparatus be available for the group to tour.

#### **Trustee Chuck Kranstuber:**

Mr. Kranstuber will be unavailable for the next regularly scheduled meeting on March 25, Mr.
Melody advised the same. After a brief discussion detailing no pressing items, it was decided to
cancel the March 25 meeting and save all business for the next regularly scheduled meeting on
April 8. If there is a matter requiring action prior to April 8, Mr. Richter will work with the Board
to schedule a meeting to address the matter.

#### **Trustee Stu Harris:**

Mr. Harris welcomed Vivian Holloway to the meeting. As a senior student at Dublin Coffman,
 Vivian is currently interning at Washington Township as part of the Dublin City Schools' Co-Op program.
