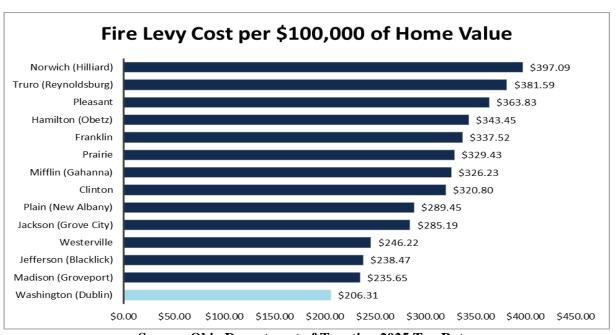

Select accomplishments over the past five years (2020-2025)

- Maintained accreditation from the Commission of Fire Accreditation International that evaluates all aspects of
 the department's operational efficiencies. The department was originally accredited in 2007, and re-accredited
 for a third consecutive cycle in 2022.
- Maintained highest ISO rating (ISO-1) during 2022, originally earned in 2018.
- Expanded community education programming to increase awareness of fire and life safety issues.
- Purchased fire apparatus and EMS vehicles in alignment with capital replacement schedule, representing approximately \$4.2 million in planned expenditures during this levy cycle.
- Implemented an annual external stakeholder meeting with local residents to address various issues that could potentially impact the township, and to brainstorm diversity and outreach efforts.
- Maintained our partnership with the City of Dublin Fleet Department to reduce vehicle maintenance costs.
- Updated our community disaster plan with a focus on notifying, evacuating, and providing temporary shelter for residents.
- Enhanced firefighter mental health program to reduce the impact the profession has on employees and overall
 wellness.
- Ohio Wesleyan University research fellow compiled an economic impact study of the WTFD outlining the return on investment from funding fire/EMS through life-saving patient recovery and reductions of property loss from fire damage, representing a net local economic impact in excess of \$140 million.

Select goals for the next five years (2025-2030)

- Continue to meet accreditation response time benchmarks by insuring at least one emergency response unit is on the scene in less than 8 minutes (from time of dispatch) at least 90% of the time. Next on-site assessment will occur in 2027.
- Maintain ISO-1 insurance rating, which positively impacts business and residential insurance rates. Next assessment will occur in 2027.
- Continue to expand community education programs to all age groups with a focus on community safety.
- Maintain and update apparatus to insure we are meeting community needs and future growth. \$2.5 million in apparatus capital expenditures are anticipated in this cycle.
- Continue to invest in technology to enhance patient care, overall response time, and communications with emergency room departments.
- Continue to enhance our employment recruitment and retention efforts to hire a skilled, diverse, and professional workforce.
- Identify and pursue new partnerships with local agencies that will enhance service efficiency and effectiveness.
- Continue to work with Dublin City schools on education opportunities and safety.
